## a. Minutes from Board Meeting 03-18-19

#### a. Finance Committee

# • YTD (February) Financials

i. At 4:23pm Ms. Jones provided an update of the YTD financials. Ms. Jones started with current cash levels, unrestricted funds for the East Harlem school, personnel expenses and other revenue from fundraising. There are some savings on the expense end, primarily due to hiring employees later than expected. There are permanent savings, but upcoming enrichment programs, consultant support (lobbyist, compliance support and technology support) will spend much of this down throughout the remainder of the school year.

# b. Per Pupil Funding Increase Efforts

• At 4:24pm Mr. Andrews addressed the Board about the ongoing efforts to secure an increase in per pupil funding. There has not yet been any movement on the school's request by the NYC DOE.

## c. Fundraising

i. At 4:54pm Ms. Richter discussed the strengths and obstacles that NYCACS has encountered with fundraising. She also presented her recommendations on how to strengthen future fundraising efforts.
